



School IPM Coordinators: 2017-2018 SCHOOL YEAR

Making the plan work:

Integrated Pest Management (IPM) training sessions for school IPM coordinators and other school personnel with Administrative responsibilities in accordance with the new IPM law. IPM Coordinators will receive certification of Attendance to fulfill the MANDATORY Training requirement as stated in the NJDEP Pesticide Control Program regulations at N.J. A.C. 7:30-13.3 Training **does not need to be repeated annually**; although people in the field do attend annually to keep up to date. The sessions will help IPM Coordinators implement the new IPM law with regards to such things as Non-Pesticide pest management; parental notification, the 72 hour notification rule; low-impact pest management; record keeping, and dealing with pest emergencies. Participating facilities managers will be able to receive 4.0 CEU's to meet the NJDOE required 20 CEU's within three year period to maintain their CEFM Certification.
